^{iv} Essential for all DCT training posts based in Primary Care setting and desirable for all other posts. Not essential for Community Dental Service posts in Northern Ireland or Wales.

^v Many DCT posts require the post holder to travel between different hospital/clinic sites within a working day.

^{vi} 'Selection centre' refers to a process, not a place. It involves a number of selection activities which may be delivered within the unit of application.

^{vii} The language skills requirements for DCT recruitment are based on those required for GDC registration.
